Sanctions for violations in the technical area

The sanctions are determined based on the frequency of rule violations and whether or not the infringement gives an advantage concerning the results. There is video footage available for every infringement that has been sanctioned.

- If athletes clearly have an advantage for breaking the rules DSQ.
- If an athlete does not benefit from breaking the rules but does it frequently a Yellow Card
- If the athlete does not benefit from breaking the rules and does it only once or twice A verbal warning.
